



Limited Lifetime Residential Warranty Coverage:

Slide-Lok warrants that garage storage cabinets ("Products") you purchased will be free from defects in material and workmanship for the normal lifetime of the Products when used by the original purchaser for single-family owner-occupied residential garage use. This limited warranty extends only to the original purchaser of the Products and is not transferable.

Exclusive Remedy: Slide-Lok shall provide replacement parts, at no charge, for any part of the Products you purchased if any part of the Products are defective. This is your sole and exclusive remedy for any defect in the Products. If Slide-Lok does not provide replacement products for any defective component or part of the Products within a reasonable time, its liability to you will be limited to the purchase price of the individual parts of the Products that are defective. We reserve the right to change and discontinue colors, styles and Products at any time without notice to you. Warranty on any discontinued colors, styles and Products will be honored by replacing with comparable Products available in the offering in the event of a claim.

Exclusions from Coverage: You will have waived any claim for warranty if you do not notify Slide-Lok in writing within 30 days after you discover a defect by sending an email to info@slide-lok.com. This limited lifetime warranty does not cover costs for installation, removal or other labor costs in connection with repair or replacement of the Products, and does not cover any defect arising from: (1) the improper installation or use of the Products; (2) abuse or neglect; or (3) normal wear and tear. **CONSEQUENTIAL, INCIDENTAL, SPECIAL, EXEMPLARY, INDIRECT OR PUNITIVE DAMAGES ARISING FROM ANY DEFECT ARE NOT RECOVERABLE UNDER ANY LEGAL THEORY.** Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not apply to you. **Limitations:** THE LIMITED LIFETIME WARRANTY DESCRIBED ABOVE IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, EXCEPT THAT ANY APPLICABLE IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, SHALL EXTEND FOR THE DURATION OF THE EXPRESS LIMITED LIFETIME WARRANTY DESCRIBED ABOVE. Customer shall allow Slide-Lok a reasonable length of time, after notice and recognition of a claim or defect hereunder, to remedy such defect by replacement in accordance with this Limited Lifetime Warranty.

This warranty shall not apply to damage caused by extended exposure to or submersion under water.

Transferability. This warranty is granted to the original purchaser and is not transferable to any other party nor to a subsequent purchaser of the property.
